

**ORDINANCE OF THE VILLAGE OF SECOR
WOODFORD COUNTY, ILLINOIS**

WHEREAS: Chapter 951/2, Article 15, Paragraph 316 of the Illinois Revised Statutes provides that local authorities, with respect to highways under their jurisdiction, may, by ordinance or resolution, prohibit the operation of vehicles upon such highways, or may impose restrictions as to the weight thereof on designated highways, which prohibition and limitation shall be designated by appropriate signs placed on such highways; and,

WHEREAS: It is the desire of the Village Board of Trustees to restrict vehicle weights to 8 tons, gross weight, on all Village streets, except those streets or portions of streets listed herein as exceptions; and,

WHEREAS: Emergency vehicles and school buses must have perpetual permission to use the Village streets, and certain service vehicles serving both residences and businesses must from time to time use the Village streets; now therefore

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF SECOR:

SECTION 1: That the load limit on all Village streets, except those streets or portions thereof listed herein as exceptions, shall be eight (8) tons, gross weight, except in the case of towed farm wagons in which case the towing vehicle and each farm wagon shall be considered and weighed as individual units.

SECTION 2: That the following streets serving as access to the business district will be excepted from the provisions of this ordinance and will be posted accordingly:

Green Street

Cruger Street

Gilman Street - between 1st and 2nd Streets

Field Street - from the west Village limit to 3rd Street

First Street - between Field and Gilman Streets

Second Street - between Field and Gilman Streets

SECTION 3: That parking of all vehicles, subject to the weight limitations of this Ordinance, shall be permitted along 1st Street between Field and Cruger Streets, provided, however, between the hours of 7:00 a.m. and 6:00 p.m. vehicles may park along the streets designated in Section 2 while loading or unloading.

SECTION 4: That school buses, and all emergency vehicles, operating for the various fire departments in Woodford County or operating under the jurisdiction and/or direction of any law enforcement agency in the State, County and/or Village and any equipment operating under the jurisdiction of the Woodford County Emergency Services Department, are exempt from these limitations.

SECTION 5: That the following limitations shall be applied for the specified service vehicles:

Fuel Trucks - empty weight of truck plus 6,000 pounds,

Gas or Electric Utility Company Trucks - empty weight or truck plus 10,000 pounds.

SECTION 6: That, upon written application and prior approval by a majority of the Village Board of Trustees, the Village Clerk shall issue a permit when a vehicle, which would otherwise violate the limitations imposed by this ordinance, is needed for a special purpose. Said special purposes shall include, but are not limited to, home improvement or repair, construction and moving.

a. The application shall specify the street or streets to be used by the vehicle, shall state the purpose for which the permit is needed, and shall specify the date or dates the vehicle will use the streets.

b. Whenever unnecessary damage to the streets may occur, the Village Board of Trustees may suspend the permit for a reasonable period of time, may direct that different streets be used or, if a reasonable alternative exists, may refuse to issue the permit.

c. When used for the stated purpose and on the dates and streets specified in the permit, the vehicle shall be exempt from the limitations of the ordinance.

SECTION 7: That all persons found in violation of the provision of Section 2 of this ordinance shall be subject to a fine in accordance with the following schedule for the first and second offense during any one calendar year:
