

Village of Secor
Meeting Minutes
November 10, 2025

President Jerry Bagby called the Village Board meeting to order at 7:00. The Village Board met in regular session with all Trustee's present.

Village Clerk, Lori Bagby read the minutes of October 13, 2025, meeting, Louise Slayton made a motion to approve minutes with corrections, seconded by Dee Dee Allen. All votes yes; motion carried.

Treasurer Greg Slayton handed out the Treasurer's report. Louise Slayton made a motion to accept the report as read, seconded by Katrina Schmitt. All votes yes; motion carried.

Greg handed out the report for all this month's bills. Louise Slayton made a motion to pay all bills out of their respective funds, seconded by Katrina Schmitt. All votes yes; motion carried.

Greg had previously handed out next year's Levy for the Board to review. He asked if there were any questions on Levy and if not, we need to vote on it. Louise Slayton made a motion to accept the Levy, seconded by Dee Dee Allen. All votes yes; motion carried.

Public Comment:

Dusty- asked about setting up a mini food pantry in town and about changing speed limit on Jones St because of people speeding.

Don Wheatley- asked about bringing our water supply in from Roanoke, Culvert on 5th and Green St. and about if our Attorney has reviewed his Attorney's letter. Jerry let him know that our Attorney does have the letter and is reviewing it.

Katrina had previously given the Board the changes in several ordinances she had updated. They reviewed them and there were no questions on them.

2025-02 Ordinance- regarding Leins for water service, delinquent water bill payment, reconnection fees. Jeff Harms made a motion to approve 2025-02 ordinance, seconded by Dee Dee Allen. All votes yes; motion carried.

2025-03 Ordinance – regarding regulation and operation of Water Works System. Katrina Schmitt made a motion to approve 2025-03 ordinance, seconded by Dee Dee Allen. All votes were yes; motion carried.

2025-04 Ordinance- regarding increase in water rates. Jeff Harms made a motion to approve 2025-04 ordinance, seconded by Dee Dee Allen. All votes were yes; motion carried.

2025-05 Ordinance – regarding prohibiting tobacco products by minor. Katrina Schmitt made a motion to approve 2025-05 ordinance, seconded by Jeff Harms. All votes were yes; motion carried.

2025-07 Ordinance- regarding live music and entertainment. Dee Dee Allen made a motion to approve 2025-07 ordinance, seconded by Jeff Harms. All votes were yes; motion carried.

Jerry asked anyone who has brown water to send a picture to him so he can provide them to the Univ of IL Students who are working on our Town Water Grant project.

Louise Slayton made a motion to adjourn the meeting, seconded by Dee Dee Allen. All votes yes; Meeting adjourned 8:04pm.
